The 2023 Alumni Luncheon

Retirees gathered at the Knott's Berry Farm Hotel for fun, fellowship, and a state-of-ACE report from John Boyle, President & CEO.



Retirees gathered January 26 at the Knott's Berry Farm Hotel for the first meeting and lunch of the new year. Keynote speaker **John Boyle**, **President & CEO of ACE**, addressed attendees, noting that despite several post-COVID challenges, there was plenty to celebrate.

Membership and insurance growth

Memberships help fund our organization. Our current tally of 17 million members should hit 18 million by the end of the year, adding 300,000 new members in 2022. Our Premier membership product – our highest level – is very popular, with 20 percent of members opting for it, making for 2 million Premier members.

We also grew our insurance product. We are the 12th largest insurer in the country, and ranked 4th in both Auto Claims and Homeowner Satisfaction in the U.S. by J.D. Power.

Pension plan update

There was also good news regarding our pension. ACE has \$2.3 billion set aside to pay

pension benefits, with more than \$125 million added over the last five years. We currently have close to 23,000 retirees participating in our pension plan, and in 2022, we paid more than \$90 million in pension benefits.

Regional operations change

The post-COVID landscape altered our facilities needs where regional headquarters are concerned. There are currently 2,000 employees at Costa Mesa Administrative Offices, 1,000 at Los Angeles Headquarters, and 1,000 at Coppell, Texas Administrative Offices. Subsequently, we will have smaller regional headquarters as we move forward.









